HONORARY TREASURER'S REPORT TO ANNUAL GENERAL MEETING TUESDAY 21 NOVEMBER 2023

Executive Summary

1. The financial year end for Bristol Law Society is 30 November. The published accounts are for the year to 30 November 2022. Copies have been circulated.

2021/22

Budget

2. We continued to work through the challenges arising from Covid with staff working from home. We held a successful annual awards dinner and we received rental income for the property.

Actuals

- 3. The Society made a pre-tax loss of £1,096 as stated in the accounts.
- 4. Income was £183,138 as against £190,186 in the preceding year.
- 5. Income profile for 21/22 includes subscriptions income, rental income from the property and the income for the annual dinner which of course always comes with substantial costs of sales figures.
- 6. The Bounceback Loan remains untouched in our #2 account.
- 7. Expenditure is made up of £47,088 cost of sales (increased slightly from the previous year) and administrative expenses of £131,183 (increased from £71,588 in the previous year).
- 8. The bulk of the difference relates to the unwinding of depreciation in 2021 (relating to the property a £35,135 charge) due to reclassifying the property as investment, increase in travel costs after Covid restrictions eased, wage and salary increases in line with inflation and increased professional costs relating to the property lease and John Moriarty's work.

Conclusions

- 9. We made an operating profit of £4,867 and a pre-tax loss overall of £1,096.
- 10. We closed the year with £75,182 cash (including the Bounceback Loan).
- 11. We remain in a very strong position with regards to the balance sheet with substantial equity in the property and rental income from the property.
- 12. A varied and successful programme of seminars were offered, and sponsorship income increased on the previous year.
- 13. Our Events and Membership Executive, Chief Executive and then Chairman continued to support a substantial programme which offered benefits and good

value to members. Thanks are due to John Moriarty, Helen and Clair who worked extremely hard with their usual spirit and commitment.

2022/23 Preview

- 14. We are projecting profit on the year in part due to rental income from the property.
- 15. BLS continued to pay off the mortgage on the property.
- 16. We ended the year with substantial cash at bank including a sum in #2 Account which included full amount received under the Bounceback Loan.
- 17. The annual dinner was successful and profitable.
- 18. We have launched a new website.

2023/24 Key Objectives

- 19. The property continues to be let on a 10 year lease with a 5 year break clause.
- 20. Next year's budget will project a profit.
- 21. Consideration is being given to the possibility of utilising the rental income to reduce our liabilities (namely the mortgage).
- 22. We continue to review our conference programme with both in-person and virtual events.
- 23. We will look towards obtaining a CRM system to ensure that we remain productive.

Investment/Property

As per previous reports:

- 24. We have converted most of our historic cash reserves into equity in property.
- 25. The estimated value of the property is £385,000 with outstanding mortgage of £133.000 as at November 2022.
- 26. Our mortgage continues to decrease by £6-7k per year with repayments of approximately £12k per year.
- 27. Going forwards the lease on the property will continue to provide income and cover expenses associated with No 12 and consideration is being given to what scope we have to reduce liabilities (BBL and mortgage) in the coming years.

I'm told it is traditional for the incoming President to make a short speech and warned it may be included within the minutes of the AGM. The note I received had the word 'short' underlined, which you'll all be pleased to know did not escape my notice, and I have followed the age old advice to follow the 3B's - 'be brief, be sincere, and then be quiet'.

I'm very proud and privileged to be the first CILEx qualified President of Bristol Law Society in its over 250 year long history. I believe it signifies a milestone change in our constitution to reflect the modern and diverse legal profession that we have in the City today. I hope that other non-solicitor legal professionals will be encouraged to play an active role in the Society, and the local legal community, as a result of that change.

While I may be the individual representation of that change, that would not be possible without the complete support and the work put in by the Executive and Solicitors of BLS, who rightly champion that change as much as their non-solicitor counterparts, and so I want to thank the BLS team and membership for their support and encouragement.

I take over from Co-Presidents Erin and Edd, who have also introduced changes that reflect the modern Legal Profession in being the first to share the Presidents' role in order to balance their young families with the demands of the role.

Indeed, their new arrivals began a trend for those in the Vice President's roles to find themselves expecting ... One that I seem to have carried on in <u>both</u> years I have spent as VP, with the arrival of my daughter Scarlett in October 2022 followed by my son Otis, 9 weeks ago. I'm not sure what is about the VP role that makes you so attractive to your partner, but I recommend the role as productive to anyone planning a family!

Joking aside, I think those examples really do highlight the level of support and encouragement that you receive from the entire BLS team, and I would not have felt comfortable taking on the role if that was not the case. Both our Chief Executive Helen, and Clair our Events & Membership Executive and PA to the Presidents, have been a great support to me leading up to this year and will continue to be in the year ahead. Edd and Erin have likewise supported by progress and under their stewardship BLS has been a continued success, and I thank them for the personal support and encouragement as well as for their hard work and dedication over the past 2 years on behalf of the BLS membership.

We would usually have me pin them some medals but I'm told they are in the post and we'll be doing that in January. While we don't have any such gift to hand, please do accept our thanks from all at the BLS exec.

For the year ahead, I hope to put a focus on Social Mobility, Equality, Diversity and Inclusion which will be reflected in my choice of Charity and initiatives for the year ahead, details to be announced in December. While there have been improvements in the profession, we are still far from providing a level playing field - not only for those who want to enter the profession, but also for those who wish to excel within it.

This doesn't merely extend to the obvious criteria of race, sex and visible disability. There are still difficulties caused by those invisible dividing factors of family economic status, access to the right standards of education, neurodiversity and invisible disabilities.

I hope during the course of the coming year, we can encourage or inspire some improvement in this area through our work. By educating firms, senior leaders, peers and colleagues on both the needs of those individuals and the benefits that they can contribute to a firm and its clients through their lived experiences; that we may encourage a younger generation to belief that they can enter the profession, no matter the circumstances of their upbringing; and that the current generation of lawyers feel inspired to embrace and respect each others individuality and create safe and fulfilling places to work, where the peak of career achievements are open to all who aspire to obtain them.

That's all from me, doubtless you'll have plenty of opportunities this year to hear me talk more. But for now I shall close by thanking the BLS members for their confidence in voting me in, and by promising to carry out the duties and responsibilities of the role to the best of my ability in the year ahead.
